City of Virginia Beach is late in payment due to computer upgrade. Final payment request from counties will be made during 1st quarter 2021 after recommendations from the Stakeholders and proposed treatment plan is received. Jeff shared the audit by Creedle, Jones and Associates for year ending June

Presentation by Andrew Howell: Improving Lyngbya wollei surveys using non-destructive echo sounding measurements. (Find report on the LGWCC website)

This process allows a number of improvements over the current system and it can be repeated. He noted the manual survey conducted in Sep/Oct will still be necessary. All aspects of the system have not been verified as to identifying all bio mass types of vegetation.

Update of Covid 19 work restrictions/activities by NCSU: (Find report on the Lgwcc website) Dr. Rob Richardson reviewed the three phases of restrictions that NCSU had to work through in 2020. He presented a time line to accomplish the tasks for the upcoming TAG meeting. (Timeline Schedule on LGWCC web site).

Monthly biosonics scan of treatment sites: April – October

Sampling of bio mass: July-October

Monthly collection of Lyngbya samples for lab analysis: July-Oct.

Field Visit to determine 2021 treatment sites: TBD

Discussion of 2021 Lyngbya Treatment Planning: Jeff Zimmer and Jessica Bauman

Items discussed:

The LGWCC would like to increase acres treated for Lyngbya up to 300 acres (including demonstration/trial treatments), begin as soon as water temperatures permit (late March/early April) and integrate new application techniques/equipment into treatments. In order to begin Lyngbya treatments by late March, contracts with applicator(s) and chemical vendor should be executed by March 1.

A timeline discussed and agreed upon follows:

• By Mid-January – a TAG meeting will be held and Lyngbya treatment acreage recommendations will be made.

- No later than February 1- Request for Proposal/Bid (RFP)will be sent by the LGWCC to vendors
- By end of February
 - A second TAG meeting will be held to discuss treatment protocols and expanded treatment areas.
 - Stakeholders meeting will be held.
 - o RFPs will be returned to the LGWCC, contract(s) awarded and vendors notified
- March 4th- TAG recommendations for treatment design presented to LGWCC.
- By Mid-March- specific treatment areas and chemical protocols conveyed to vendors.
- Late March/early April-(water temps exceed 64 degrees F) treatments begin

Discussion to capture/develop a history of LGWCC efforts to eradicate undesirable aquatic weeds and improve water quality: Elton Brown.

There is agreement on the importance to develop and communicate a history of the LGWCC's success in control of Hydrilla and improving water quality on Lake Gaston. Steve Hoyle will determine the efforts needed and provide development cost estimates.

Other Discussions before the council:

Should the LGWCC take a position on real estate development projects on Lake Gaston: Tabled till next meeting.
