The Lake Gaston Weed Control Council (LGWCC) is soliciting bids for Aquatic Herbicides and Algaecides to be applied at Lake Gaston during the 2021 Treatment Season. This is a contract for delivered **chemicals only** and does not include application.

Over the last four (4) seasons, the LGWCC has purchased an average of 2000 lbs. Fluridone pellets and 3500 gallons of liquid Algaecides. While the specific products and volumes to be purchased are still to be determined for 2021, we anticipate a similar volume of Fluridone and a significant increase in Algaecides (times 3 or 10,500 gallons) and associated products. Chemicals for each treatment will be ordered separately by applicator(s). We anticipate three (3) treatments of Fluridone and three (3) to six (6) treatments of Algaecide during the season.

Applicator(s) Role - Applicator(s) under contract to the LGWCC will place orders periodically during the treatment season (late March to late October) directly with the Chemical Vendor. Applicator(s) will have the ability to accept deliver of order(s) during normal business hours.

Chemical Vendor Requirements

All products are to be the most current label and of recent production, packaged to meet Department of Transportation (DOT) specifications.

All products will be delivered in compliance with all applicable Federal and State laws, rules and regulations.

Vendor will offer pick up for recycling on any and all empty containers.

Vendor will deliver the ordered product(s) to a location designated by applicator(s) within five (5) business days of order being placed. Delays in order being received will result in a 10% penalty for that order.

LGWCC will make prompt payment to vendor upon receipt of order(s) and invoice(s).

Bid Process

LGWCC asks for terms and pricing on a number of aquatic herbicides and algaecides as we continue to refine the protocol for our treatments. **Please utilize the attached bid form.** Chemicals which have been purchased and utilized in recent treatments **are in bold** and will be the major component of bid evaluation.

LGWCC reserves the right to accept or reject any and all proposal.
